Councilman Bell made a Motion to accept the Zoning Commission recommendation and accept the first reading of Chapter 50 Division 9 amendments as presented. Councilwoman Cline seconded the Motion. Motion passed unanimously with seven (7) for and none (0) against.

Item # 210614— Discussion and Possible Action — Zoning Commission Recommendation
Consider amendments to various sections of the City's Zoning Ordinance
under Chapter 50 for the purpose of providing amendments and additional
regulations pertaining to accessory buildings and uses.

Councilman Wahl made a Motion to accept the Zoning Commission recommendation and accept the first reading of Chapter 50 amendments pertaining to accessory buildings as presented. Councilman Bell seconded the Motion. Motion passed unanimously with seven (7) for and none (0) against.

Item # 210615 – Discussion and Possible Action – Receive Information from Robb Starr, Lumberton Municipal Utility District concerning their Bond Election.

Mr. Robb Starr, Lumberton M.U.D. came forward to address Council at this time. Mr. Starr advised that he wanted to inform Council of MUD's upcoming bond election. Mr. Starr stated that the current sewage treatment plant is 25 years old and is over capacity for organic waste. Mr. Starr further stated that current treatment plant design is "incredibly small in comparison to the new state standards". Mr. Starr advised that this would be the largest bond to date, and if passed residents would pay approximately \$11.00 per month per \$100,000.00 valuation. The other option would be an increase of approximately \$40.00 per month on the water bills. Mr. Starr further stated that he has much information available and will be holding Public Information/Education meetings twice monthly until the November election date. Much further discussion followed however, this was an informational item only and No Action was taken or required.

Item # 210616 - Discussion and Possible Action - First Reading - An Ordinance Amending City of Lumberton's Code of Ordinances, Chapter 35 - Parks and Recreation, to provide for additional regulations and prohibitions concerning the use of city parks.

Councilman Wahl made a Motion to accept the First Reading – Ordinance amending Chapter 35 – Parks and Recreation as presented. Councilman Burkhalter seconded the Motion. Motion passed unanimously with seven (7) for and none (0) against.
