MAYOR'S REPORT:

Mayor Surratt congratulated Chief Sullins on a job well done by his officers. LPD officers apprehended three individuals who were found with drugs and three loaded firearms, two of which were stolen. They were also found to be in possession of empty backpacks with ski masks and gloves inside.

Mayor Surratt also commented on a recent drug bust wherein LPD canine unit, Ayton, assisted in the arrest. Chief Sullins stated that he is very proud of the job that the canine units have done. He said that BPD sends their dogs to train in Kerrville once or twice a year and when they do they call LPD to cover their calls. Recently, they were called out three times in one week.

CITY MANAGER'S REPORT:

City Manager Steve Clark reminded the Council that the City has been working with Hardin County on a grant which would provide funds for a detention pond. Initially, the City was supposed to be responsible for 25% of the cost. However, after Senate Bill 7 passed, it enabled the City to be reimbursed for all but 6% of

the cost. The County is requesting that the City pay \$1,358,690.00 (25% of the total cost) up front. The City will be reimbursed as the grant funds are released. There was much discussion by the Council on what the best way to proceed would be. The Council decided that the City would pay the 25% up front and the County will then reimburse the City as the grant funds are released. This project will cost approximately five million dollars.
