Grantee's records; requiring Grantee to pay a franchise fee; providing for conditions of the franchise; providing for construction of this ordinance upon the invalidity of any part thereof; providing for acceptance of this franchise by grantee and both an effective and operative date thereof; repealing all previous gas franchise ordinances; providing for severability; providing for publication and prescribing an effective date.
