Councilman Maniscalco made a Motion to accept the minutes as presented. Councilwoman Cline seconded the Motion. Motion passed unanimously with six (6) for and none (0) against.

Item #240911 – Discussion and Possible Action – Zoning Commission Recommendation Request submitted by Denise Anderson, of Costcorde, LLC., to replat Lot 3A and Lot 4A Park Central, Vol. 4, Pg. 312, Plat Records, into Lot 3B Park Central. The property is located at 285 Country Lane, Park Central, Lot 3A, Abstract No. 46 in the R C Rogers Survey and Abstract No. 14 in the Elisha Duncan League, and 206 S LHS Drive, Park Central, Lot 4A, Abstract No. 46 in the R C Rogers Survey, and Abstract No. 14 in the Elisha Duncan League, Lumberton, Hardin County, Texas.

Councilman Bell made a Motion to accept the Zoning Commission Recommendation and approve the replat of Lot 3A and Lot 4A into Lot 3B. Councilwoman Cline seconded the Motion. Motion passed unanimously with six (6) for and none (0) against.

Item #240912– Discussion and Possible Action – Zoning Commission Recommendation Request submitted by Travis Odom to encroach upon his side building setback line to widen and extend his existing concrete driveway to within 2' of the side property line. The property is located at 6636 Georgetown Lane, Westwood Heights, Block 11, Lot 6, Lumberton, Hardin County, Texas.

Mayor Pro Tem Schoen made a Motion to accept the Zoning Commission Recommendation and approve the request as presented. Councilman Maniscalco seconded the Motion. Motion passed unanimously with six (6) for and none (0) against.

Item #240913 – Discussion and Possible Action - *Zoning* Commission Recommendation Request submitted by Clayton and Jennifer Gregory to replat Lot 3A and Lot 3B into Lot 3. Abstract 21 in the Charles A. Felder League. The property is located at 360 Fletcher Road, Lumberton, Hardin County, Texas.

Councilwoman Cline made a Motion to accept the Zoning Commission recommendation and approve the request to replat Lot 3A and Lot 3B into Lot 3. Councilman Maniscalco seconded the Motion. Motion passed unanimously with six (6) for and none (0) against.

Item #240914 – Discussion and Possible Action – Liveoak Environmental, LLC – Request for rate increase.

Sonny Hubbard with Liveoak Environmental, LLC came forward to present this item. Mr. Hubbard explained that Liveoak Environmental is requesting a 3.8% rate increase. This will raise the single residential rate from \$13.78 to \$14.30 per month. There was much discussion regarding the issues that residents have been having with Liveoak Environmental such as late pickup, billing issues wherein residents are not receiving their bill and then receiving threatening letter from the company for non-payment, lack of ability to reach the company by phone, and poor customer service. Mr. Hubbard acknowledged that the issues with billing and the phone service were their fault and that the company is working to resolve the issues. Councilman Bell stated that because the increase is not based on performance but is based on information from the Consumer Price Index, he made a Motion to approve the 3.8% rate increase, effective October 1, 2024. Mayor Pro Tem Schoen seconded the Motion. Motion passed with four (4) for and Councilwoman Cline and Councilman Maniscalco (2) against.
