A. APPROVAL OF MINUTES OF SEPTEMBER 23, 2024 PUBLIC HEARING AND REGULAR MEETING

Councilman Wahl made a Motion to accept the minutes as presented. Councilwoman Cline seconded the Motion. Motion passed unanimously with seven (7) for and none (0) against.

NEW BUSINESS:

Item #241011 – Discussion and Possible Action – Zoning Commission Recommendation Request submitted by Shawn Verinsky to encroach upon his rear and side building setback lines to construct a 24'X30' accessory building, on a concrete slab, to within 5' of the rear and side property lines. The property is located at 6650 Woodridge Drive, Westwood Heights Subdivision, Phase II, Section A, Blk 6, Lot 13, Abstract No. 2, in the Francisco Arriola Survey, Lumberton, Hardin County, Texas.

Councilman Bell made a Motion to accept the Zoning Commission recommendation and approve the request for a variance to within 5' of the rear and side property lines. However, the accessory building must be in compliance with the maximum 500 square feet as stated in Ordinance Section 50-537(2)b. Councilman Maniscalco seconded the Motion. Motion passed unanimously with seven (7) for and none (0) against.

Item #241012— Discussion and Possible Action — Zoning Commission Recommendation Request submitted by Chad Hood, Sr. to encroach upon his rear building setback line to construct a 12'X16' accessory building on a concrete slab, to within 16' of the rear property line. The property is located at 6300 Jenny Lane, Woodridge I Subdivision, Block 2, Lot 10, Abstract No. 2, in the Francisco Arriola Survey, Lumberton, Hardin County, Texas.

Councilman Maniscalco made a Motion to accept the Zoning Commission recommendation and approve the request to construct a 12'x16' accessory building to within 16' of the property line. Mayor Pro Tem Schoen seconded the Motion. Motion passed unanimously with seven (7) for and none (0) against.

Item #241013 – Discussion and Possible Action - Zoning Commission Recommendation Request submitted by Shannon Trevathan to install a separate electrical meter can to an accessory building in the back yard. The property is located at 240 Southland Drive, Beaumont Colony South, Block 1, Lot 15, Lumberton, Hardin County, Texas.

Councilman Maniscalco made a Motion to accept the Zoning Commission recommendation and approve the installation of a separate electrical meter can to the accessory building in the back yard. Councilman Wahl seconded the Motion. Motion passed unanimously with seven (7) for and none (0) against.

Item #241014 — Discussion and Possible Action — request submitted by Patrick Hoffman of Brampton Essential, LP, to approve the Final Plat for Longleaf Subdivision Section 1A. The property is approximately 21.12 acres of land being a portion a called 20 tract H.C.C.F. No. 2019-99601 H.C.D.R. and a called 2,095 Acre Tract HCCF No. 2016-66227 H.C.D.R. being situated in the Edwardo Arriola League, Abstract No. 1, Lumberton, Hardin County, Texas.

Councilman Bell made a Motion to approve the Final Plat for Longleaf Subdivision Section 1A. Mayor Pro Tem Schoen seconded the Motion. Motion passed unanimously with seven (7) for and none (0) against.

Item #241015 - Discussion and Possible Action - First Reading - An Ordinance of the City of Lumberton, Texas amending Chapter 48 (Traffic and Vehicles) Section 48-3 of the Code of Ordinances to incorporate the Texas Department of Public Safety's speed zone survey dated 05/16/24 implementing reduced speed of 50 mph along US FM 3513, mile points 2.348 - 3.234.

Councilman Wahl made a Motion to accept the First Reading of an Ordinance amending Chapter 48 (Traffic and Vehicles) Section 48-3 to reduced speed of 50 mph along US FM 3513, mile points 2.348-3.234. Councilwoman Cline seconded the Motion. Motion passed unanimously with seven (7) for and none (0) against.
