<u>DISCUSSION AND INFORMATION CONCERNING THE FOLLOWING:</u>

1) Request submitted by James Anderson to encroach upon his east side and rear building setback lines to within 5' of both property lines, to construct an 8'X8' accessory building on skids (Section 50-537 City Ordinances). The property is located at 6910 Woodridge Drive, Westwood Heights, Phase IV, Section A, Block 10, Lot 11, Abstract #2, in the Francisco Arriola Survey, Lumberton, Hardin County, Texas

Zoning Secretary Anita Price presented this item. She stated that this is a standard request and the Zoning Commission voted unanimously to approve the request as stated.

- 2) Discussion and possible public comments of the following proposed amendments to the City of Lumberton Code of Ordinances Chapter 50 (Zoning), Division 6. C-2 Community Business District:
 - Sec. 50-332 Use regulations, to exclude game rooms as a permitted use
 - Sec. 50-341 Game rooms, to prohibit game rooms and the operation of amusement redemption machines.

City Attorney Curtis Soileau presented this item. Mr. Soileau stated that this Amendment eliminates the use of game rooms within the City Limits. Neighboring towns, such as Jasper and Beaumont have already implemented this Ordinance. The Zoning Commission unanimously approved this amendment.
