City Attorney Curtis Soileau presented this item. Mr. Soileau referred the Council to the report from the City Inspector regarding the Ordinance Violation of Uninhabitable Mobile Home. He stated that the City has received complaint letters from three neighbors complaining of the danger that the mobile home poses. Their complaints included the mobile home poses a fire hazard, a safety hazard, and rodent issues. The property has been abandoned for years. Chief Sullins also reported that the Police Department has received numerous calls about teenagers going into the mobile home. Mr. Soileau stated that, according to the report, the mobile home does pose a significant safety hazard and is a public nuisance. Councilman Maniscalco made a Motion acknowledging that the mobile home at 106 Oleander constitutes a public nuisance and set a Public Hearing for the matter for October 27, 2025 at 6:30 p.m. Councilman Schoen seconded the Motion. Motion passed unanimously with six (6) for and none (0) against.
